- A formal tracking system is needed for college readiness
- All actions need shift focus from compliance to implementation
- Reemphasize withdraw codes are correct
- A system is now in place to monitor all seniors who are failing one or more classes

- Shift verbiage on monitoring to tools from "having" to "using"
- Discuss with leadership the shift to implementation and encourage them to utilize the accountability sheets when implementation is not happening
- Ask for data on the college application coordination effort
